



### DECLARATION OF CONFORMITY – FOOD SAFETY

We declare, that SERWACH Spolka z ograniczona odpowiedzialnoscia Spolka Komandytowa, 1 Maszewska Street, PL72100 Goleniow, Poland is registered at the Sanitary inspection register as a company which produces corrugated cardboard packaging for indirect contact with food. Our packaging can be uses for indirect contact with food. Impermeable, physical barrier must be used in order to separate food from packaging.

We declare produced by SERWACH packagings comply with the requirements for packaging for indirect contact with food. The requirements are included in the following acts:

- Regulation of 25 August 2006 on safety of food and catering (OJ from 2006, No. 171, item No. 1225 with later amendments),
- Regulation (EC) No. 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC,
- Commission Regulation (EC) No. 2023/2006 of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food,
- European Parliament and Council Directive 94/62/EC of 20 December 1994 on packaging and packaging waste,
- Regulation of 13 June 2013 on management of packaging and packaging waste (OJ from 2013, item No. 888 with later amendments),
- Regulation of The Minister of Environment of 21 January 2015 on a method of determining the sum of lead, cadmium, mercury and hexavalent chromium in packaging (OJ from 2015, item No. 170),

Based on declarations from our suppliers we declare that produced by us corrugated cardboard packaging:

- Meet a requirement for maximum sum of lead, cadmium, mercury and hexavalent chromium, that is < 100 mg/kg.
- Are made from cardboard from production process in which there were not used such additives as Teflon, latex, silicon, formaldehyde, halides, sulphur compounds, plant protection agents, material of animal origin and other prohibited substances.
- Are made from cardboard from recycled, cellulose and mixed materials in a production process which reduces amount of hazardous and harmful to environment substances. Cardboard does not transfer to the food substances in quantities which pose a threat to human health or cause changes in the composition of food and the deterioration of its organoleptic characteristics.
- Are suitable for material recycling.
- Do not contain substances of very high concern (SVHC) from the list published by the European Chemicals Agency (ECHA) or at least not above a concentration of 0.1%.

What is more SERWACH company does not import and manufacture chemical agents and products which are subject to registration in accordance with the REACH regulation.

Declaration of conformity is valid for one year from the date of its issue or until a new version is released (available on webpage [www.serwach.com.pl](http://www.serwach.com.pl)).
